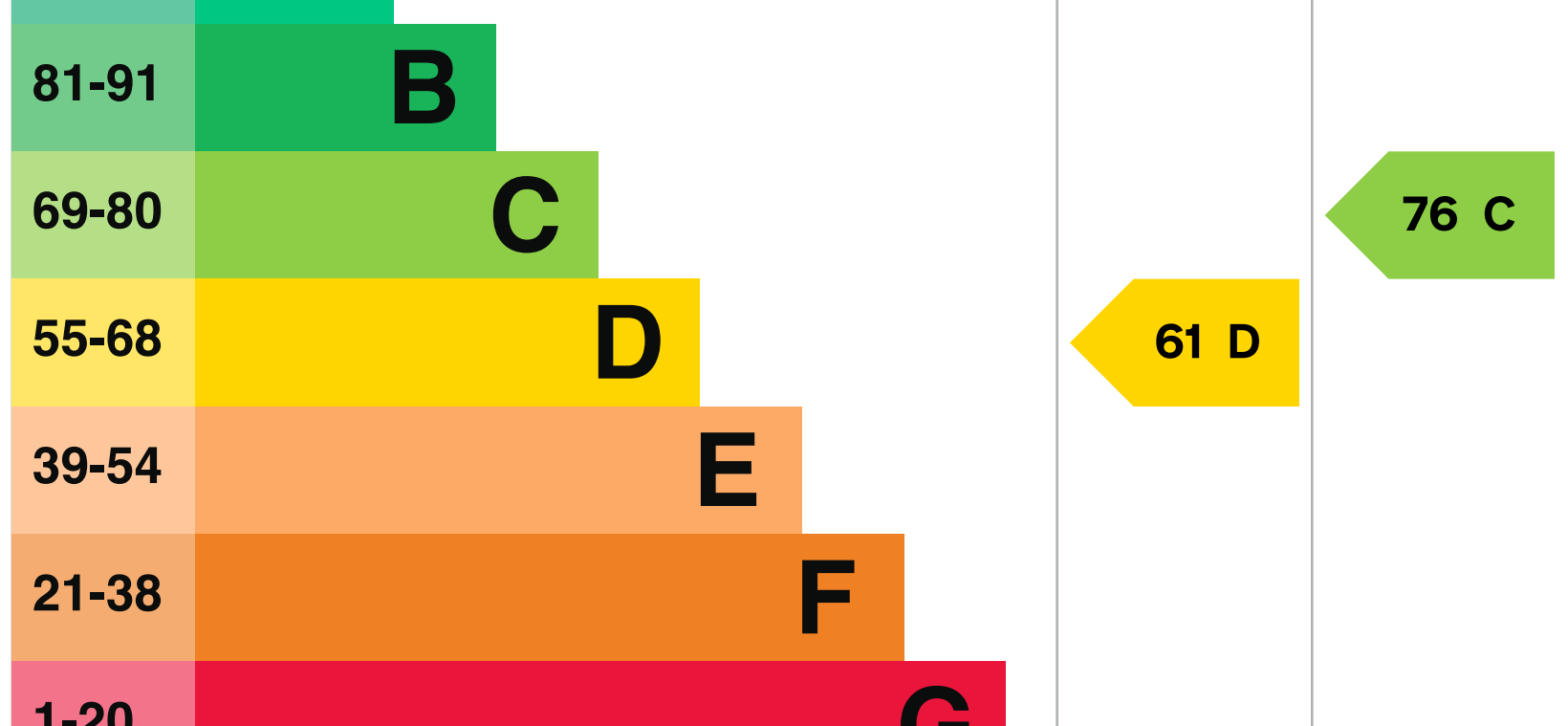

## How this affects your energy bills

An average household would need to spend **£2,404 per year on heating, hot water and lighting** in this property. These costs usually make up the majority of your energy bills.

You could **save £974 per year** if you complete the suggested steps for improving this property's energy rating.

Estimated energy needed in this property is:

- 17,139 kWh per year for heating
- 2,408 kWh per year for hot water

## Impact on the environment
